

NYSSHA FRU 2024 Rules, Regulations & Entry Information.

- 1 The Show Committee reserves the right to add, cancel or combine any classes in accordance with NYSSHA rules.
- 2 **All horses on the show grounds must have a legible, current Coggins (2023 or 2024) and a current Rabies certificate (dated after Sept. 20, 2023) available for inspection.**
- 3 It is strongly suggested that the first 4 classes be pre-entered. **Pre-Entries must be postmarked by 9/14/24.** Post entries will be charged \$1 extra per class. Any classes scratched at least three classes in advance will not be charged for. One number will be assigned for each horse/rider combination. Classes must be entered two (2) classes in advance and must be paid for as entered, unless there is a blank check on file in the entry booth. **All returned checks will be charged a \$50.00 fee.**
- 4 Tack changes must be reported to the show office two (2) classes in advance. A time limit of no more than three (3) minutes between classes, including tack changes.
- 5 Please refer to the NYSSHA Rule Book regarding eligibility for classes entered. It is the exhibitors responsibility to know the rules for their own divisions and enter the correct classes. A current rule book will be available at each show for reference. NYSSHA rules govern the show, but exhibitors need not be NYSSHA members to show, however, to point for year end awards, membership in a NYSSHA member club is required.
- 7 Horse Show Entry Fees and Awards:

Leadline:	\$5 fee per class with Award & 6 placings
SMS/Eq/11&under	\$7 fee per class with Award & 6 placings
Schooling (all ages):	\$8 fee per class with 6 placings
In Hand/Pleas/Performance	\$10 fee per class with 30% of the entry fees collected paid back at 1st-50%, 2nd-30% & 3rd-20% with 6 placings
Day end awards:	The show committee reserves the right to not award a day end award to any division or combination of divisions with less than 6 competitors.
- 8 Horses staying overnight must be stalled. **No stalls will be reserved without pre-entries.** Stalls used for any purposes must be paid for. Stalls found to be In use without being paid for will be charged a \$10 penalty plus the stall fee of \$50/weekend. Horses may not be brought onto the fairgrounds before 5 PM on Friday. Stabling will be done by the show chairman. Do not put your horse in a stall before checking with the show staff or consulting the posted stabling chart. Unstabled horses will be charged a \$5.00 fee per day.
- 9 Camper hook ups will be available on a first come, first served basis for \$80/weekend and paid for with entries. Campers found to be hooked up without payment will be charged a \$25.00 penalty plus the camper fees. Dry campers will be charged \$30/weekend and paid for with entries.
- 10 All dogs on the show grounds must be leashed at all times. If a dog is found to be unleashed, the owner and the dog may be asked to leave the show grounds. For safety purposes, dogs are not allowed in the arena and should not be near the holding area or gate. Owners of aggressive or nuisance dogs will be asked to remove them from the show grounds. No entry fees will be refunded if this occurs.
- 11 Schooling classes are open to any exhibitor and schooling equipment may be used. Riders must ride at the gaits they are showing at. WTJ (all ages) and Academy WTJ may show in In schooling 2 gait, whereas, Academy WTJCL may school at both 2 & 3 gait. 2 gait horses may school at 3 gait without penalty and 3 gait may school at 2 gait without penalty. Schooling classes are not NYSSHA pointed.
- 12 Crossrail Rider and Hunt Seat Rider classes are based on rider ability, not horse ability.
- 13 **No alcohol or glass containers are allowed inside the arena.**
- 14 **No trailers or cars may be parked by the barns.**
